
## Coleytown Middle School Building Committee

Due to staffing and productivity challenges related to Covid-19 pandemic, the reopening of CMS will be delayed.

- Coleytown Middle School is now scheduled to open for students and staff by mid-October.
- Work will continue on the exterior of the building until December.

Every step is being taken to ensure the new schedule is maintained. Risks to the new schedule will be communicated to the Town and the BOE every week.

## Coleytown Middle School Building Committee



- EnviroMed will report on the satisfactory condition of the building prior to the opening.
- The new projection for the opening of CMS by mid-October.
- As with all projects, this date is subject to field and manpower conditions

## Project Update

## Site Work and Grading

 Work underway. Beyond the required grading to address moisture, the entrance area will also be improved.

### **Interior Work**

 Significant progress to date. Beyond the new HVAC, Library/Media Center and Science rooms, there will be new and greatly improved lighting throughout the building and other enhancements.

### Roof

 Installation of the new roof underway with faster than expected progress to date.

### Windows

- Supply Chain challenge addressed.
- All old windows removed in preparation for new curtain wall windows.

### HVAC

- Supply Chain challenge addressed and Units have been delivered.
- Temporary dehumidification units installed and operational.

## Cladding

• Shop drawings completed and no supply chain issues are expected.

- Awarding of VOYA grant which made connection between Pathways and the Senior Center possible.




## Increase in the number of students needing supports for anxiety-depression-ADHD

## Goals



- Develop plans that are in line with community needs relative to the reopening of schools and communicate these plans to all district stakeholders.
- Develop a plan that ensures an effective distance learning program in the event school closures extend beyond the 2019-20 school year.
- Define and assign roles and responsibilities, including work groups charged with articulating essential functions, needs, and actions.
- Assess where additional capacity and support may be needed from external partners to support the Reopening of School Committee's work.
- Develop strategies, including financial and procurement considerations, for securing assistance.

## Scenarios



- Summer school programs, including Extended School Year (ESY), taking place in June, July, and August 2020
- Schools reopen on time in September 2020 and remain open
- Schools reopen on time in September 2020, but close due to prevalence and spread of COVID-19
- School reopening is delayed in September 2020 due to the prevalence and spread of COVID-19

### **Working Group - Health and Safety**



### **Primary Responsibility:**

Identify health and safety concerns and establish procedures and protocols necessary to reopen schools, including protocols for closing schools in the event there is an increase in the prevalence or spread of COVID-19.



## **Working Group - Facilities and Operations**



### **Primary Responsibility:**

Identify health and safety concerns that impact daily operations and develop protocols and plans for potential modifications to facilities and transportation services.



## **Working Group - Teaching and Learning**



### **Primary Responsibility:**

Create plans for curriculum, instruction, and assessment for the 2020-2021 school year that include, but are not limited to, reopening schools in September 2020, an extension of school closures, and/or additional school closures during the school year.



## **Working Group - Co-curricular**



### **Primary Responsibility:**

Create plans for co-curricular activities for the 2020-2021 school year that include, but are not limited to, reopening schools in September 2020, an extension of school closures and/or additional closures during the school year.



### Timeline

### Phase I

During the months of May and June the Steering Committee, with support of its working groups, will develop initial recommendations for the Board of Education's consideration. An update will be provided to the Board of Education at its June 8, 2020 meeting.

### Phase II
